CHAP 658 LAWS OF 1985

Introduced by COMMITTEE ON RULES -- read twice and ordered printed, and when printed to be committed to the Committee on Rules

AN ACT to amend the county law, in relation to the term of office for a sheriff, county clerk, county treasurer or coroner

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Subdivision one of section four hundred of the county law,
2 as amended by chapter one thousand seventy-one of the laws of nineteen
3 hundred sixty-five, is amended to read as follows:
4 1. Elective. There shall be elected a sheriff, county clerk, dis-
5 trict attorney and county treasurer. Except in the county of Lewis,
6 coroners shall continue to be elected as now provided by law until the
7 office is abolished or the number is increased or diminished pursuant to
8 the provisions of this chapter. [The] Unless otherwise provided in this
9 chapter, the term of office of each such officer shall continue to be
10 three years, except that the terms of office of sheriff, county clerk,
11 county treasurer and coroner shall be four years from and including the
12 first day of January next succeeding his election. There shall be
13 electd a county judge, surrogate, and judge of the family court as now
14 or hereafter provided by law. The term of office of each such judicial
15 officer shall be ten years from and including the first day of January
16 next succeeding his election.
17 § 2. This act shall take effect immediately.
