SUBJECT: Chapter 658, Laws of 1985 (Fixing terms of Sheriff,
County Clerks, County Treasurers and Coroners.)

Enclosed please find a copy of the above Chapter of the Laws of 1985 amending Section 400 of the County Law effective on July 28, 1985 the date upon which the Chapter was signed into law by Hon. Mario M. Cuomo, Governor.

This amendment provides that all county sheriffs, county clerks, county treasurers and county coroners elected after July 28, 1985 shall serve four year terms beginning on the first day of January following their election unless the county law itself should provide an exception as to any particular county.

These terms had previously been for three years. This amendment does not affect the term of office of District Attorney. That is also defined in a previously adopted subdivision of Section 400 of the County Law which should be consulted if the length of term of District Attorney becomes a matter of concern in administration of the Election Law.
