Question Regarding County Executive's Term of Office

This memorandum is in response to your request for an opinion regarding the term of the County Executive. Specifically, you asked whether MaryEllen Odell is currently serving her first or second term of office, given the fact that she was elected in a special election in November, 2011 to serve the three (3) remaining years of the previous four (4) year term (January 1, 2011 – December 31, 2014).

The Putnam County Charter provides that "[t]he County Executive shall be elected from the County at large in an even numbered year for a term of four (4) years commencing on the first day of January immediately following his or her election. He or she shall serve a maximum two (2) consecutive full terms". Put. Cty. Charter §3.01. Since the previous term that she served was not a full term, as is dictated by this section of the Charter, she is currently serving in her first full term.

Furthermore, as is cited above, the term limit contained in this section restricts her term of office to two (2) consecutive full terms. Since she is currently serving in her first full term, she is legally permitted to run for one more full term for the office of County Executive.
