Per your request, the following is a list of Trustees for the Village of Brewster who have resigned and those who were appointed to replace them since the November election:

1. Joseph Lambert resigned 12/3/2001 – term would have expired 12/2003.
2. Dianna Tricinelli appointed 12/12/2001 – to replace Joseph Lambert. Dianna needed to run for a one-year term in 11/2002 to fulfill original term of Joseph Lambert expiring 12/2003.
3. Michael Cesare resigned 3/13/2002 – term would have expired 12/2002.
4. William C. Banks appointed 3/20/2002 – to replace Michael Cesare to fulfill term expiring 12/2002.
5. Dianna Tricinelli resigned 6/12/2002.
6. John Gillen appointed 7/10/2002 – to replace Dianna Tricinelli.
