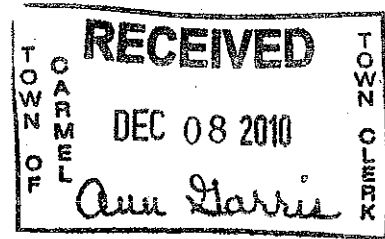

Effective midnight December 31, 2010, I will resign from my position as Town Councilman and Deputy Town Supervisor.

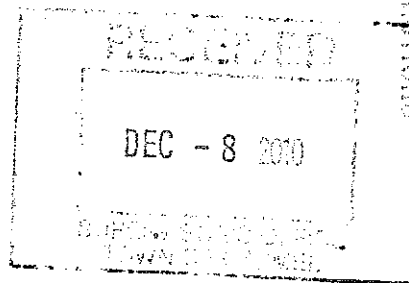
It has been a privilege and a pleasure to serve on the Town Board for the past seven years. I look forward to working with you on the County level.
