NOW, THEREFORE, BE IT

RESOLVED, pursuant to the authority vested in the Town Board pursuant to Section 64(5) of the Town Law, the Town Board hereby appoints MICHAEL E. BRUEN as Interim - Acting Superintendent of Highways, to be compensated at a rate of pay equal to that which was established for the Superintendent of Highways in the Town Budget; and be it further

RESOLVED, the foregoing appointment shall take effect on November 16, 2013 after MICHAEL E. BRUEN'S execution of his oath of office and shall expire on December 31, 2014 pursuant to Section 64(5) of the Town Law.
