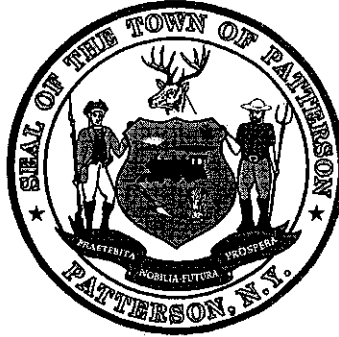

I will notify you if and when another person is appointed to that Board.

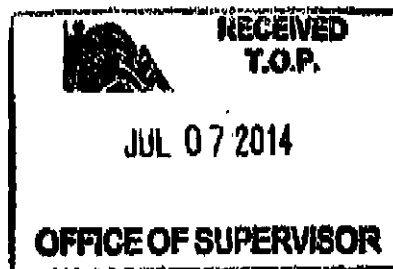

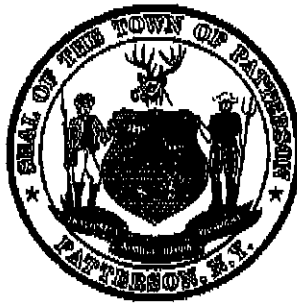
