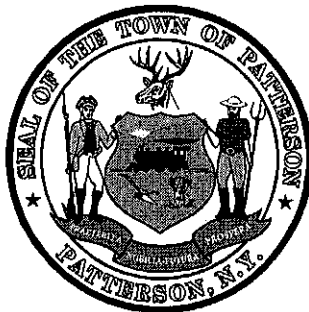

WHEREAS, the Town Board has determined that Michael Caruso has exhibited the experiences, qualifications and other attributes necessary to serve as Town Justice.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Patterson hereby appoints Michael Caruso to serve as Town Justice to fill the unexpired term and until his/her successor is duly elected and qualified; and

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby authorized and directed to take all necessary action to give effect to this Resolution.
