1. §4-108 "Whenever any proposal, proposition or referendum as provided by law is to be submitted to a vote of the people at an election conducted by the Board of Elections, the clerk, at least thirty-six days prior to the election, shall transmit to the Board of Elections a certified copy of the text of such ballot proposal, proposition or referendum and a statement of the form in which it is to be submitted. If a special election is to be held, such transmittal shall also give the date of such election."
2. In addition, the transmittal shall contain an abstract, concisely stating the purpose of the question and the form of the ballot proposal.
3. §4-106(4) Within three days after the occurrence of a vacancy, the clerk is required to file with this office a certificate indicating the vacancy and the position which is to be filled.
4. §6-158(14) A vacancy occurring before September 20, in any Public Office, to be filled at a General Election, shall be filled at the NEXT GENERAL ELECTION.
5. An Individual appointed to an elected office must be elected to remain in office until the term expires.
