Dear Joseph:

I hereby resign the elective office of County Legislator for District #7 as of midnight this date. I had been previously elected to this public office at the general election held in November of 1989. The term of office for this position was two years, and thus, a vacancy of one year remains to be filled. At the same time, I must resign from the appointive office of Deputy Chairman of the Putnam County Legislature. Further, I can no longer serve as Legislative representative to the Putnam County Soil and Water Conservation Board, and further resign as Vice-Chairman of that Board as well. In addition, the Putnam County Charter prohibits me from holding any other political office or position. I hereby declare my resignation from the elected political position of County Committeeman of the Republican Party in Putnam County.

I look forward to serving as Putnam County Executive starting on January 1, 1991.
