CARMEL, NY - Putnam County Board of Elections Commissioners Catherine P. Croft and Kelly K. Primavera have announced temporary changes to poll locations for the June 24, 2025, Primary Election only. **Please call The Board of Elections at (845) 808-1300 to confirm your eligibility.**

### **TOWN OF CARMEL - Townwide & Legislative District 5 - Republican Primary ONLY**

**Mahopac Middle School** voters will use **Mahopac Falls Elementary**, 100 Myrtle Ave., Mahopac, NY.  
**Austin Rd Elementary** voters will use **Doherty Hall at St James**, 20 County Center, Carmel, NY.  
**Lakeview Elementary** voters will use **Carmel Town Hall** at 60 McAlpin Ave, Mahopac, NY.

### **TOWN OF KENT - Legislative District 5 - Republican Primary ONLY**

**Lakeview Community Church** - ONLY Republican voters who live in Kent Election Districts 3, 5, and 9 will be voting at Lakeview Community Church.  
**Kent Volunteer Fire Dept.** and **Kent Town Hall** - *DO NOT* have a Primary Election.

### **TOWN OF PUTNAM VALLEY - Townwide Republican Primary ONLY**

**Putnam Valley High School AND Tompkins Corner Fire Department** voters will use **Putnam Valley Ambulance Corps**, 218 Oscawana Lake Rd, Putnam Valley, NY.

### **TOWN OF SOUTHEAST - Legislative District 6 - Republican and Conservative Primaries ONLY**

**Lakeview Manor** *only* voters who live in **Southeast Election District 1** will vote at **Brewster High School**, 50 Foggintown Rd., Brewster, NY.  
**Brewster VFW** *only* voters who live in **Southeast Election District 7** will vote at **Brewster High School**, 50 Foggintown Rd., Brewster, NY.  
**Brewster Public Library** *DOES NOT* have a Primary Election.

### **TOWN OF PHILIPSTOWN - Townwide Democratic Primary ONLY**

**Continental Village Clubhouse** voters will use **Garrison Volunteer Fire Dept.**, 1616 Rt 9, Garrison, NY.  
**North Highlands Fire Dept.** voters will use **Cold Spring Methodist Church**, 216 Main St., Cold Spring, NY.

**These poll site location changes are for the June 24, 2025, Primary Election only**, and voters should expect to return to their usual poll sites for future elections, unless advised otherwise. Only voters registered in political parties having a primary are eligible to vote in the June 24, 2025, Primary Election.
